The International Wealth Index (IWI) is an asset-based index that measures the economic situation of households in LMICs on the basis of their ownership of assets, housing quality and access to public services. IWI runs from 0 to 100, with 0 meaning none of the assets and lowest quality housing and services and 100 all assets and highest quality housing and services ([Smits & Steendijk, 2015](#)).
